

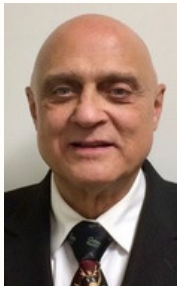

WORTHY MEMBERS OF 5073

Brothers:

I am restricted in providing any further information concerning the upcoming meeting on September 9th. Even though I am compelled to set the facts straight, "Facts #1 to #6", I am bound by the by-laws of the Kolumbus Club concerning the protocol of presenting information in the proper manner as were all other members of our council.

The proper protocol was always at a meeting of the members only. Below you will find an exert of the e-mail sent by David Gelinas, Ontario State Advocate, Ontario Accountability Officer, which supports my interpretation of the by-laws. It is with this e-mail in mind that the executive has called all the members of 5073 with the following message, approved by David Gelinas:

On September 9th there will be a general meeting. One of the items under new business will be proposals to decide the ability of the hall to provide a viable location for the running of the business of 5073. As stated in the by-laws, information will be provided at the first meeting only, and the members will decide by a majority vote if to proceed to a second meeting to vote on the future of the hall.

The first meeting will be informational and only a majority needed to give permission to proceed to a second meeting. The second meeting will only proceed when approved by a majority in the first meeting.

If a second meeting s required, notice will be given in writing to all members or in the newsletter at least five days prior to the second meeting. The second vote that will take place requires a two-thirds (2/3) vote.

Aware of a notice of intended sale of the land and premises at 2400 Industrial St in Burlington was printed in the Council's June bulletin and a notice of motion was made at the council's June general meeting,

State Deputy David Peters and myself have agreed that we need Grand Knight Rocco and the executive to follow these steps to ensure every member from Council 5073 is completely aware of an upcoming meeting.

We need the executive to either phone every member and notify them of the topic of discussion and date of the September meeting and stress the importance to attend or to send out a letter from Grand Knight Rocco and mail every member on the roster. If you choose to call the membership, messages left are not good enough, you must speak with every member and make them aware of the details of the September meeting.

Aware, there have been at least four fact sheets distributed to the membership already, I ask that no other communication be sent to the membership with the exception that I listed in the paragraph above to notify the membership. Please instruct the Kolumbus Club president and executive of this directive. We ask that all remaining facts and data be keep for the upcoming meeting where all points of view will be allowed equal time to speak to the membership.

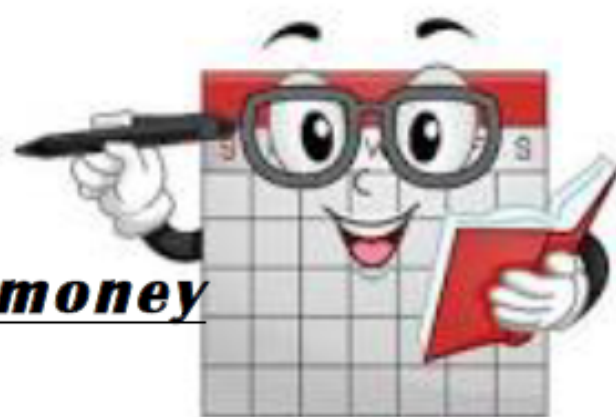
