- Articles must be submitted on time for each issue, which is the last day of the calendar month. Late

submissions will be inserted in the following month's newsletter.


- Proofread your article carefully for spelling and grammar before sending (use spellcheck or a software such as Grammarly). Advice: read your articles out loud to get a sense of tone.

ONE OF THE INTERESTING things about serving in various roles with the State Council over the past few years—as State Deputy and then as Membership Director—is that I have a vast number of Newsletter Articles from prior years to harken back on.

Looking back on my article from last year this time, I noted that we needed about 400 new members to reach our Circle of Honor goal and that we had trended about 10% behind the prior year in 2022-2023 to that date.

Well, as I write this article with about a quarter to go, we are doing better than the prior year and are at roughly 72% of our intake goal, needing about 350 new members these next three months to reach our

Circle of Honor Goal once again. We are ranked as the 4th overall in Division 2 (of 11 Jurisdictions) 31st overall out of 75 Jurisdictions, so in the top 40%, which is the highest we have been since 2022 when we ranked as the 4th overall in Division 2 and 29th overall. We have the opportunity to surpass last year's intake before we get to State Convention in Mid May—and our success will be a result of every Council taking advantage of this last quarter and leaving no 'stone' unturned. We have many councils that can still achieve their membership quota set by Supreme and potentially become a Star Council. We have as well roughly 120 councils that have yet to bring in a new member—what a great opportunity for every council to become active in bringing in at least 1 new member these last three months. If every council brings in just one new member, we will reach our goal (as we will also have some e-members join).

Approaching every eligible Catholic man, and giving them the opportunity to join the Knights will be the key to this! I hope all of you take the following quote to heart: that regardless of age, every man can be offered the opportunity to join the Knights that was shared for so many years by Jim Stachura. Some of you may know Jim from his many years of service as a Field Agent and helping establish new councils throughout Wisconsin. Jim passed away just yesterday, at the age of 82 after faithfully serving the Knights for the last 54 years! Over hundreds of men are Knights today because of Jim's effort in approaching, engaging, and welcoming them to join the Knights!

This Lent is a great opportunity to take advantage of approaching these men during Mass and inviting them o pursue the effort of giving them this great opportunity to join the Knights. Jim believed that the Knights can help lead us all on the path to heaven! I look forward to the day in the future where we all are once again in the presence of Jesus Christ with Jim at our side! *Vivat Jesus*!

AS OF MARCH 25, we have assigned a total of 497 new E-members since July 1. This is 25% more than all of the prior Fraternal Year, and we still have 3 months to go. So far Councils have transferred 383 E-members into Councils this Fraternal Year. Roughly 50% of Council Intake this year has been through E-members. Currently just over 30% of the Councils in Wisconsin have used Online Membership to bring new members into the order this year. Thank you to all the Councils that are utilizing E-membership to grow their membership.

Cards with the QR Code to join online are available from Supreme. These can be very helpful when inviting men to join. Your Diocesan Membership Directors and District Deputies should be able to help you get these cards if you need them.

WGK & WFS please frequently review your councils PROSPECT tab and if you are having difficulty in making contact, or any other issue, please email me regarding these outstanding assigned e-members and I will gladly assist you with reaching a remedy.

The **PROSPECT** tab shows you emembers that have joined online via the Supreme app. and the date field is used to transfer them into your Council when they have completed their exemplification. With Emembership, new members enter their own data, and them confirm their membership when they receive an e-mail from Supreme. These Emembers are then part of the State Council, and get assigned to a local Council. Until the local FS enters the Exemplification date, these members remain part of the State Council. Local Councils get credit for them when the Exemplification date is entered by the FS to transfer them into your Council. Prospect tab training is available here.

Supreme presented a Webinar in December on Transferring online members to council membership -The link for that webinar is <u>here.</u> The **CANDIDATE** tab is what you use when you recruit a member locally or are handling a member transfer request or a reinstatement of a prior member. The Candidate tab can best be described as an online Form 100. The candidate tab <u>training</u> covers new members and transfers into local councils.

Again, the date field is the date they were exemplified by your council. Once you enter those dates in either tab, the members will be automatically transferred to your council's roster within the next week.

Do not send Form 100's to Supreme for new members, keep them for your council's records. If you must use a Form 100, Scan it and email it to Supreme. Keep the Original for your Council Records. Since Form 100's must be manually processed at Supreme, they can lead to data entry errors and delays. Utilizing E-membership or the Candidate Tab for new members are the preferred ways to bring in new members.

STATE ADVOCATE DAVID KREUTZ



IT WAS EARLY JANUARY in the heart of Wisconsin, where the cold rolling hills meet the frozen lakes. The Knights of Columbus stand united, dedicated to the mission of faith, community service, and compassion. Each year, this esteemed organization channels its efforts into supporting individuals with intellectual disabilities. With the aid of its local councils, the Wisconsin Knights of Columbus transform generosity into tangible support—building bridges toward a more inclusive community.

On January 4, 2025, members of the Knights of Columbus' Intellectual Disabilities (I.D.) Committee gathered at a local parish in Plover, WI. The atmosphere buzzed with a shared commitment to uplift those who often face barriers in society. The committee, composed of volunteers from various dioceses across the state, was meeting to approve grants for programs directly impacting the lives of individuals with intellectual disabilities. They would soon have a profound effect in many towns and cities across the state.

As the meeting commenced, the members sifted through a hefty stack of grant requests, each detailing passionate aspirations to enhance program offerings. The collective focus was on empowering individuals and fostering a sense of belonging. Bennie Green, the ID Committee Chair, led the proceedings, reminding everyone of the importance of their mission and the lives they were about to positively impact.

In an unwavering show of generosity, the committee approved a total of \$115,000 to be distributed among 29 worthy initiatives.

One of the standout projects was Miss Amazing, an event dedicated to showcasing the talents of girls with disabilities. With a grant of \$9,000, the event would provide a venue, awards, and support for the day, creating an atmosphere of celebration and acceptance that will light up the lives of many participants.

Another heartwarming grant was directed towards Easter Seals Wisconsin, which received funding for ten camperships. These grants would enable children and adults to attend camps designed specifically for their needs, fostering lifelong friendships and invaluable experiences.

The Arc of Racine County was buoyed by a grant of \$2,350 to assist in program expenses and transportation costs. Having access to tablets for learning purposes would enable participants to explore a new world of knowledge, stimulating both mind and spirit.

Across the state, programs like Best Buddies, Life Navigators, and Washington County Birth to 3 received funding to address unique needs, from organizing dances and tailgate events to supporting early intervention strategies for children, respectively. Each dollar allocated represented hope, recognition, and empowerment for individuals who might otherwise feel overlooked.

In the southeastern part of the state, Shepherds College received a grant for essential appliances, ensuring their students could enjoy a unique and enriching educational atmosphere. Meanwhile, in the far southwest of the state, the Opportunity Center celebrated its grant of \$10,000 directed towards repairing loading docks—an improvement vital to its operational efficiency and the well-being of those served.

The echo of approval wrapped warmly around the room as motions were passed: \$4,800 for a trip to Disney on Ice offered an unforgettable experience to clients of The Arc of Dodge County; \$5,000 for a sensory room at Horace Mann would create a haven for students needing specialized tools for learning; and \$4,000 for You Belong ensured that basic educational supplies were in the hands of those who would thrive with them.

KNIGHTS OF COLUMBUS POLITICAL GUIDELINES

I HOPE THIS MESSAGE finds you in good spirits. I am writing to clarify an important matter regarding our organization's stance on political endorsements, especially as discussions surrounding candidates for state and federal office continue.

As loyal members of the Knights of Columbus, it is our duty to uphold the integrity and mission of our Order, which is grounded in Catholic values and focused on charity, unity, fraternity, and patriotism. It is crucial to understand that the Knights of Columbus is a strictly nonpolitical organization. This guideline is clearly outlined in Article II, Section 189 of the Knights of Columbus Laws and Rules, which states:

"The Order is strictly nonpolitical, but its members are not prohibited from participating in political affairs as individuals;

they are, however, admonished that they represent themselves only and not the Order."

This means that while each of you is free to express your personal political beliefs as individuals, endorsing specific candidates or political parties during Knights of Columbus meetings or through official channels is strictly prohibited.

Moreover, our nonpolitical status is essential in maintaining our designation as a 501(c)(3)organization, along with our subordinate councils classified as 501(c)(8) under the IRS guidelines. Engaging in political activities—beyond personal advocacy—could jeopardize our tax-exempt status and compromise the integrity of the Knights of Columbus as a charitable organization. I recognize and appreciate your commitment to causes that align with our Catholic values, such as pro-life issues. However, it is critical that we navigate these issues responsibly, ensuring our actions reflect the values we cherish without compromising the foundational rules of our Order. I encourage all members to think creatively about how we can promote our principles and engage in meaningful discussions within the framework established by our Supreme Council. Should you have any questions or need further clarification regarding these

guidelines, please do not hesitate to reach out. Thank you for your understanding

and for your continued dedication to our mission. *Vivat Jesus!*

delegates to the Supreme Convention. The State Deputy and the Immediate Past State Deputy automatically serve as the first two delegates. The remaining eight delegates are selected by the vote of those delegates attending our State Convention. Delegates to the Supreme Convention must be 3rd Degree Knights, and at least half of the eight must be Insurance Members.

The Supreme Council reimburses Delegates per diem at \$400 per day for 3 days and mileage at \$.30 per mile one way.

Again this year, the Wisconsin State Council offers the opportunity for those seeking election to be Delegates to the Supreme

Convention, to submit a resume and nomination Statement to be posted on the State Website. This information allows the Councils the opportunity to know the delegates and who they were voting for prior to the State Convention. Delegates to the State Convention will meet during the Saturday afternoon session to nominate and elect deserving members who may represent them at the Supreme Convention. Per the State Council Bylaws, only seated Delegates can make nominations and have the privilege of a vote; although non delegates can be nominated. Previous delegates to the Supreme Convention should not seek a nomination in order that other members be given a similar

opportunity to serve as a Supreme Delegate. It is very desirable that Delegates to the Supreme Convention be Knights who have been extraordinary in promoting Charity, Unity, Fraternity and Patriotism in the Knights of Columbus. Upon returning, Supreme Delegates are expected to share their experiences at local Council. Assembly. District and Diocesan meetings. The Delegates to this State Convention should be made aware of this Knight's accomplishments by the nomination speech given on his behalf. Materials can be emailed to me.
