OUR 1ST QUARTER Fast Start results have been fully tabulated for the July-September time frame. Several districts and individual councils have stepped up to the Fast Start challenge. Some have even surpassed their objectives and are already at 100% or more of the yearly membership goal, became Safe Environment compliant, and completed their Fraternal Benefit Events goals, all in a 3-month period.

Our challenge is to have every council active. What does that mean? It means simply every council needs to add one new member to their roster, and they are considered being active.

With the excellent performance by the above Districts & Councils, we should have easily made our 1st Quarter goal of 248 new members as of the end of September if every council was active. However, we still have a great number of councils that have yet to being in a single new member this fraternal year.

Our Goal was 248 new members in the 1st Ouarter. We achieved 241 We were short 7 new members.

My sincere thanks and appreciation to all of you who have taken my initiative to heart and have gotten ahead of the curve on timely

compliance of your reports & member intake. You are "On Mission!"

We are now into our 2nd Quarter which historically has a higher influx of new men joining with councils ending their summer breaks and vacation schedules and getting back to regular monthly meetings and church drives and programs.

Stay tuned: New incentives are being announced for this quarter and should have been relayed by your District Deputies or Diocesan Directors at the time of this newsletter release.

By being active and effective in our Programs, Church, and Community we can become the Fishers of Men that Blessed Father McGivney laid out for this organization in 1882. Let's not let him down at this critical time in our country where our faith is being challenged, and our men and families are being disillusioned. Men are willing to join an organization where they can bond, share a common desire to maintain, and stand up for their Catholic Faith.

Our accumulative goal year-todate is 50% of our annual goal, or 618 new members, by December 31st. We already have 308 as of October17th. Therefore, we only



need 310 new members by the end of December. With every council becoming active and inviting one new man to join their council and be exemplified, this should be a simple objective with us having over 300 councils.

Those councils that have not yet brought in a new member, are you ready to step into the breach and help us ensure that this great organization will continue to support the poor and less fortunate for another 140+ years?

Let's become the Fishers of Men that are so needed at this time.

Your State Officers & staff are working diligently to finalize the Dec 6-8 Winter DD meeting registration & agenda.

All District Deputies should make every effort to attend this semiannual mandatory meeting by registering on the State Website today. Block the date in your calendars.

AS THE MONTH of November unfolds, let us pray to God with sincere hearts. It is necessary for us each to intercede with our hearts and minds to God on behalf of our brothers and sisters.


Many of us are aware that we live in interesting times. So much is at stake. There is a battle against the devil playing out before our eyes. Evil is being exposed and is about to come undone.

AS WE CLOSE out October, it is hard to believe how fast time has flown by once again. Many of your Councils conducted a Membership Drive in October or are soon to do one this November. Most of our Councils are still in need of conducting their first Exemplification since July—and we encourage all to at least conduct ONE if not TWO exemplifications between now and December 31st to ensure we have 'Every Council Membership Active.'

I am writing this article for you all on November 2nd, after returning from a memorial ceremony for All Souls Day at our Parish Cemetery. As I was attending with my wife and mom in memoriam of my dad who passed away this past February, following Mass I was called on by our Parish Priest to assist him by carrying the bowl of blessed 'Holy Water' as we walked around the graveyard to bless the gravesites of those in attendance for all their loved ones who have gone before us. When calling on me, he even mentioned 'I have a nice Knights of Columbus member' who will assist me, thus recognizing all the efforts that the Knights do to support our Priests (not just calling me by name as his friend).

Now, I bring this up as it was quite the challenge walking around this graveyard in 40 degree temperatures carrying close to a gallon of holy water in an awkward bowl (no arm workout needed for me today). I truly felt blessed to walk around and observe and witness Father Jim Baraniak's ability to console and also remember every one of these

individuals that passed away in this past year. Speaking fondly and kindly of each to all of their families and giving another remembrance to each of the departed.

One of the families was parents of a 20 year old kid who passed away this past year. Those few extra moments the priest spent with them probably meant the world to all of these families! In daily life, our Priests are constantly called on to be there in times of need for individuals, to celebrate the good times in baptism and weddings, but also in times of need with the passing of loved ones, sometimes entirely unexpected. Our Priests lead us through these emotional roller coasters and I can't help but imagine how challenging that can be at times outside of the day to day challenges of leading a Parish and being a faithful servant to lead them in Faith. So quite simply: When our Priests have a need, there is a Knight there to serve.

We continually need to have more new Knights to continue to serve our Priests and our Parish Communities, helping to at least lessen some of the burden that they are faced with day to day.

This was the vision that Blessed Fr. McGivney had in forming the Knights. He wanted us to be there to 'help' those in need, to help 'families' in need, whether it is to support for the loss of a loved one with our Fraternal Benefits program to the various charitable efforts we conduct and promote.



As we celebrate All Souls Day, I challenge you to think about this month at your next Council meeting. I want you to reflect on of all those Knights that have passed away in the past year, but also all those members of your Council that went on to eternal life. Our works we do is continuing on the vision and legacy of Blessed Fr. McGivney but also carries on the legacy of all those members that came before us. We continue to need new members to ensure that the Knights of Columbus and our councils carry forward for another 140 plus years as we have since our founding. Hopefully this month of November, leading into Advent and as we celebrate the 'birth' of our Savior, we can reflect on those that have come before us and celebrate a 'new start' once again by bringing in additional new members into your councils.

LATELY, SOME MINOR grievances have arisen within the council, which could have been resolved internally if certain members had known the proper procedures for addressing their concerns. It is crucial to bear in mind that our council possesses all requisite mechanisms to function autonomously, without any external intervention. Nonetheless, there may be occasions where the standard protocol falls short in providing a viable solution to the issue at hand, in which case the grievance may need to be elevated to the next level. Councils must recognize that the Knights of Columbus is comprised of 16,000 councils worldwide, and it would be an insurmountable undertaking for the Supreme to address grievances that disregard established protocols and directly approach the Supreme Council.

Filing a complaint within a Knights of Columbus council typically involves the following steps:

- 1. Identify the Issue: Document the issue or concern you have. Include specifics such as dates, times, and any individuals involved.
- **2. Gather Evidence:** Collect any supporting documents or evidence that substantiate your complaint. This could include emails, written statements, minutes, records, or photos.
- **3. Review Council Bylaws:** Familiarize yourself with your council's bylaws and procedures for handling complaints. This ensures

you follow the correct protocol. The bylaws can be provided by the Grand Knight, Council Advocate, or State Advocate through Officers Online.

- **4. Contact the Advocate:** Reach out to the council's Advocate, who handles legal and procedural issues within the council. They can guide you on how to proceed.
- **5. Formal Written Complaint:** Write a formal complaint letter. Include your name, contact information, detailed description of the complaint, evidence, and any witnesses.
- **6. Submit the Complaint:** Submit your written complaint to the Grand Knight, who is the presiding officer of the council, or to the council's Advocate.
- **7. Investigation:** The council will investigate the complaint. This may involve interviewing witnesses, reviewing evidence, and holding meetings.
- **8. Resolution:** Based on the findings, the council leadership will take appropriate action. This could range from mediation to disciplinary measures.
- **9. Follow-up:** Stay in contact with the council leaders to ensure your complaint is being addressed and to receive updates on its status.
- 10. Appeal: If you are not satisfied with the decision, you may have the option to appeal to higher authorities within the Knights of Columbus, such as the District Deputy or State Advocate.

Ensure you maintain records of all correspondence and documentation



related to the complaint throughout the process.

If your complaint within a Knights of Columbus council is not resolved to your satisfaction, you can take the following steps:

- 1. Request Clarification: Ask for a detailed explanation from the council leadership regarding why the complaint was not resolved. This can provide you with more insights and potentially clarify misunderstandings.
 - 2. Appeal to Higher Authorities:
 - ▶ District Deputy: If the council fails to address your complaint, you can escalate it to the District Deputy, who oversees several councils within a district.
 - State Advocate: If the
 District Deputy cannot
 resolve the issue, appeal to the
 State Advocate, who handles
 legal and procedural issues at
 the state level.
 - 3. Follow Formal Appeal

Procedures: Ensure you follow the formal procedures for appealing a decision. This usually involves submitting a written appeal outlining the unresolved issues and your desired outcome.



- 4. Mediation: Request mediation between you and the involved parties. Mediation can sometimes lead to a mutually satisfactory resolution.
- **5. Supreme Council:** As a last resort, you can appeal to the Supreme Council, the highest authority within the Knights of
- Columbus. Provide comprehensive documentation and evidence supporting your case.
- **6. Consult the Bylaws:** Review the Knights of Columbus bylaws for specific guidance on handling unresolved complaints and appeals.
- 7. Seek External Advice: If internal processes are exhausted without resolution, you might seek

advice from an external advisor familiar with organizational disputes.

Throughout this process, maintain professionalism and keep detailed records of all communications and evidence related to your complaint and its handling.

AS OF OCTOBER 15, we have assigned a total of 156 new Emembers since July 1. That is an increase of 59 in 1 month. Thank

So far Councils have transferred 114 E-members into Councils this Fraternal Year. Roughly 45% of Council Intake this year has been through E-members. We are a little behind where we would like to be here.

A major focus this quarter is to get Every Council and Every District Active. We currently have 47 pending e-members from last year, and 72 more pending e-members from this year, assigned to 80 Councils in 43 Districts. If we can Exemplify these 119 E-members and get them into Councils, it would significantly increase the number of Active Councils and Districts.

Grand Knights and Financial Secretaries can find these Assigned E-members on their Prospects Tab in Officers Online. Please make it a

priority to reach out to these Emembers this month and bring them into your Councils via an Exemplification.

As you are doing your programs & church drives, be sure to include the E-membership online invitation app in your invitation process to potential members.

WGK & WFS please frequently review your councils Prospect Tab and if you are having difficulty in making contact, or any other issue, please email me regarding these outstanding assigned e-members and I will gladly assist you with reaching a remedy.

Remember:

The **Prospect Tab** shows you emembers that have joined your council online via the Supreme app. and the date field is used when they have completed their exemplification.

The **Candidate Tab** is what you use when you recruit a member locally or are handling a member



transfer request or a reinstatement of a prior member.

Again, the date field is the date they were exemplified by your council. Once you enter those dates in either tab, the members will be automatically transferred to your council's roster within the next week.

Do not send Form 100's to Supreme for new members, keep them for your councils records. If you must use a Form 100, Scan it and email it to Supreme - Keen the Original for your Council Records.

FOURTH DEGREE DUANE ZABOROWSKI & JACK WRBANICH

THE FOURTH DEGREE of the Wisconsin Knights of Columbus held two scheduled exemplifications in the month of October – October 12, 2024 on the Eastern Side (Green Bay) and October 19, 2024 on the Western Side (Platteville). Over 60 brother Knights became Sir Knights at these degrees. Supreme has declared that the goal for each Assembly is to be a STAR Assembly which basically starts with an increase in new members equal or greater than 6% of your current membership. If your Assembly has 96 current members, your goal would be 6 new members for the year from July 1, 2024 thru June 30, 2025. We will be working with the State Officers and all third-degree Grand Knights to help in increasing the number of men joining the 4th Degree! The challenge to the Councils that the State Deputy and the Masters are making is this – over 80 percent of third-degree members are not fourth degree. Please invite them to take the degree. And the challenge to the Assemblies and their members is to continue recruiting, not only third-degree members to move up but to bring new members into the Councils so that we all "win".

Members of the Patriotic Degree are an integral part of the Order, and we serve our brother Knights, we proudly foster patriotism in each nation in which we are active

and we act on what is right and honorable. Being an honor guard is only part of the 4th Degree. The uniform is what makes us visible but it is the other things that we do that will make us more visible as Knights. Without the uniform, you can still participate in funerals, masses, meals, helping the parish and the priests by doing some activities as 4th degree and others with Council members. There is nothing that says a 4th degree Assembly cannot do a fundraiser for a pregnancy center and get the matching funds from Supreme. Help out at a VA Center, work with your local Veteran groups, participate in the Valentines for Vets program with your local schools and deliver them to a veteran's home. These are a few examples of things you can do without the uniform.

Related to Honor Flights from the state of Wisconsin, there are a few that are still scheduled for the fall. You can support Honor Flights by making donations to support a veteran being on the flight, being in attendance when the flight returns from Washington DC and greeting their return or write letters to be given to the veterans at Mail Call on the flight. Also, the cost of the uniform did go up after 5 years at the former price. The new price for the uniform will be \$475 which was effective September 1, 2024. The 4th degree has been charged with increasing the number of Sir Knight with uniforms. Continued on pg. 12.

AS YOU ARE reading this you will be at the end the period of both secular and religious services that the Church referred to as Allhallowtide. Yes even Halloween had a religious origin as it came from the Eve of All Saints Day, originally called All Hallow's Eve, and All Saints day was called was originally called Allhallos. The final day of this Triduum is All Souls Day when we pray for all those in purgatory. This is also the time as knights we should have a memorial service to remember and pray for all past members.

Looking into the near future, Thanksgiving Day is only a short few weeks away. Thanksgiving is the day that may be a secular Holiday but its meaning is more than just giving thanks at a big Turkey Dinner. It is the day where we need to give thanks for the harvest after the long growing season. What better way to give thanks than through offering it to Our Lord in the Eucharist attending mass. Remember our first order is Charity and what better time than Thanksgiving to spread our blessings to those who are in need with donations to local food pantries or other agencies that provide a meal for the homeless. Remember donations do not have to be cash, but offering your time and service is often even more important.

A big program in the spirit of Charity and Faith, that was created by our State Council years ago, called the "Sentiments for Seminarians." Each council is asked to advertise for our seminarians the need for cash cards or gas cards that will be presented to the seminaries throughout Wisconsin to help with the daily needs of the seminarians. These Cards will then be passed on to your District Deputy to bring to our winter meeting starting on Friday December 6th. At the meeting all cards will be collected and distributed directly to the Seminaries before Christmas.

This is also an ideal time to remind you of the RSVP program. Remember that it is a custom for our Councils to support our Seminarians as much as possible. This includes praying for them, inviting them to our meeting and social events to show them our support and helping them financially. Supreme wants to encourage this program by returning assistance to the Councils and Assemblies that support our seminarians by reimbursing them with \$100.00 for every \$500 they donate to a seminarian. Remember you need to complete two forms for full credit and the reimbursement of forms. Form2863 RSVP refund Application with a copy of the checks needs to be submitted to Supreme. Form #10784 Fraternal Programs Report needs to be submitted as well to Supreme. Remember to also copy and submit a copy of all forms to the state at Forms@wikofc.com to receive state credit and a back up if questions pop up.

YCAT bibles are still available. I will have them to distribute to those Districts that ordered them at the Winter District Deputies meeting. If



you need them before then send me an email or call me at 262-470-4477. To order them go to the State web page and select the blue button labeled "State Council Store" to pay with credit card. Check payment can be sent to either the State Office or me, directly to me at the with checks made out to "Wisconsin State Council K of C". However, to ensure we have sufficient copies to fill all the orders at the meeting, please send me your order in advance. The cost remains at \$12.50 per bible.

Pilgrim Icon. Currently we have roughly a month before Supreme has requested us to return the St. Joseph Icon to them. There were a few councils that claimed they never had a chance to get the ICON so I'm currently trying to get them the ICON before it is returned. Come early 2025 Supreme has promised us a new Item of the Sacred Heart which will be rotated. Looking back at the history of the St. Joseph ICON, it was in Wisconsin for three rotations. The first rotation went smoothly, and the second rotation went well. However, on the third rotation many councils canceled out of the program creating gaps and confusion. With this being the first rotation of the NEW ICON, I'm anticipating a much smoother rotation. Continued on pg. 12.

Guidelines For Political Activity

Knightsare first and foremost Catholiccitizens who are members of their communities and constituents of their elected officials. A citizen most effectively petitions his elected official as an individual voter. Ordinarily, there is no need to refer to one's membership in the Knightsof Columbus when petitioning an elected official. Themessage we want to send is "I am an informed constituent who has a principled stand [against / in favor of] your public policy choices and I vote." As Pope Emeritus Benedict XVI reminded us: "It is imperative that the entire Catholic community in the United States comes to realize the grave threats to the Church's public moral witness." [1] To help members answer this call to faithful citizenship effectively, the Knights of Columbus provides the following list of political activity "DOs and DON"Ts":

DOs

- DObecome active in the political life of your local community;
- DOregister to vote and encourage others to register to vote;
- DOinitiate and participate in robust "get out the vote" efforts to bring voters to the polls in all primary, general, and special elections;
- DObecome informed on public policy issues of fundamental interest to the Catholic Churchat the local, state, federal, and international levels;
- DObecome acquainted with public policy initiatives of the national conferences of Catholic Bishops as well as state and provincial Catholic conferences;
- DOstudy and reflect upon the teachings of the Catholic Churchso as to develop a well-formed Catholic Conscience a good place to start would be to review relevant sections of the Catechism of the Catholic Church, available at http://www.vatican.va/archive/ENG0015/ INDEX.HTM;
- DOorder booklets on specific issues of fundamental importance to Catholics published by the Catholic Information Service, http://www.kofc.org/un/en/cis/index.html;
- DOshare with others the Catholic Church's teachings on moral issues of fundamental importance to society;
- DOadvocate for Catholic positions on local and national legislative and other issues of fundamental interest to the Catholic Church. This includes participation in action alert announcements that seek to make the voices of Catholic citizens heard on legislation of fundamental interest to the Catholic Church;
- DOwrite letters to the editor of local newspapers;



- DOknow your elected representatives and their positions on issues of fundamental interest to the Catholic Church;
- DOcorrespond with your representatives and let them know that you support the Catholic position on issues of fundamental interest to the Catholic Church;
- DOthank representatives for their actions taken on issues of fundamental interest to the Catholic Church;
- DOjoin the Supreme Counciland your State Councilin advocating for public policy issues. When doing so, echo the sentiments and wording the Supreme Councilor your State Council have already articulated; and
- DO VOTE!

DON'Ts

- DONOTengage in any partisan political activity in the name of the Knights of Columbus. Partisan political activity is defined as including activity that seeks to endorse or oppose a candidate or party in a campaign for public office.
- DONOTmake partisan political statements in the name of the Knights of Columbus. A partisan political statement is defined as including statements that seek to endorse or oppose a candidate or party in a campaign for public office.
- DONOT, on behalf of your local council, congratulate or admonish public officials in the name of the Knights of Columbus.
- DONOT, on behalf of your local council, take a position on a matter of public policy unless you are joining a position the Supreme Councilor your State Councilhas already articulated;
- DONOT distribute any Knights of Columbus member lists or contact information to political campaigns or to individuals running for office;
- DONOTuse an official fraternal title in connection with your personal political activity, except to convey biographical information; and
- DONOTuse Knights of Columbus facilities, including, but not limited to, email accounts, social media, fax machines, letterhead and the like, in connection with partisan political activity.

Newsworthy • Broad Appeal • Concide • Complete • Factual • Accurate Answers the Questions: Who, What, When, Where, Why, & How

- > Articles should contain a minimum of 300 words (ideal) but no more than 600 words max. Articles that are longer than this may be shortened by the editor.
- > Articles should be submitted to the State Secretary by email as a Word document attahment.
 - ▶ PDF submissions are for **ads** or **promotions**, not **articles**.
- ▶ Pictures need to be sent separately as an attachment and the original pictures. Include photo information and credits. **Please do not format them in any way; we will do it.** Do not embed them within your Word document. Consider providing photos whenever possible. It makes the newsletter more interesting to look at and read.
- ▶ Articles need to be brief, highly relevant, and actionable.
- ▶ At a minimum, Who, What, When and Where needs to be in the **first** paragraph.
- ▶ Articles need to be brief, to-the-point and **of interest** to the entire State Council:
 - What is the event/activity about?
 - Whom did it benefit?
 - What was the result?
 - Who are the key players/Knights?
- ▶ Similar story submissions will be consolidated/batched into one article by the editor.
- > Authors must submit on time for each issue, which is the last day of the calendar month. Late submissions will be placed farther down the newsletter or not published.
- ▶ Proofread your article carefully for spelling and grammar before sending (use spellcheck or a software such as Grammarly). **Advice:** read your articles out loud to get a sense of tone.
- ▶ There is no need to put two spaces after periods for new sentences. That is an outdated method!
- ▶ Please name your filenames with your name, title, and newsletter month (e.g. Hopper, Joshua Editor Jan24).
