As we finish the first quarter of our fraternal year, it is time to assess how we are doing.

- We are currently -38 Net/Net in Membership
- 69% of Districts are Active in bringing in new members
- 23% of Councils are Active in bringing in new members
- 29% of Councils are Safe Environment Compliant
- 18 Councils with 2 FBN already.

When the state Officer Team met in April and May, we put together a plan with hopes of really making a difference. We had a plan to grow programs, fraternal benefits, and membership. We asked District Deputies and Council Leaders to join us in this plan to grow the Knights of Columbus in the State of Wisconsin.

We put together a set of goals, and a plan to meet those goals. These goals were then shared with the District Deputies, with a request to work with the Councils in their Districts to make things happen. Some of the Major Goals were Growing in Membership in every Diocese, District, and Council, Growing our Programs to donate more hours and dollars, and to have at least 2 Star Councils in every District. Some would look at these goals and question if they are possible. Yet we do have a plan to get there.

This plan does require every Diocese, District, and Council to do their part. If we are to grow and truly help as many people as we can, we need to start with prayer. I pray that you are all well and are enjoying the blessings of our order. I'd like to talk about the honor of a Knight of Columbus.

As a new state chaplain, I'm getting used to being certainly more active with Knights of Columbus than I've ever been. It has always been a yes for me from the beginning. From the first moment that I was invited to join the Knights as a seminarian, I did not hesitate to say yes to each opportunity as a Knight of Columbus. I've been blessed to be active in four councils as a priest, and three of them as chaplain. Whenever I had an opportunity to show my face at a K of C event, I gladly do it. I enjoy making the meetings that I can. It's an honor to be part of this group that does so much for the Church.

One of the things that you will notice about the Knights is the way we dutifully address each member with respect in our meetings. Knights often use the man's title as a Knight and an officer in our order. Worthy Grand Knight! Worthy Warden! Worthy State Deputy! As a regular guy, this can take getting used to. Even for a priest, who has accepted the title "Father", there's something new about this use of titles and honors. Or perhaps it's really something old.

There are three ways that I would like to offer for how to think about these titles and honor that comes with them.

The first thing to notice is the use of the word worthy. Each day we need to ask God to make us worthy of the life He calls us to. Fulton J. Sheen used to say that "Life is Worth Living". In fact, all of life is worth our full attention and effort. When you call someone worthy, let that be a reminder to them that their presence makes a difference. Each man's contribution to our order makes a great difference in its success both humanly and eternally. Make sure that the people you depend on know that you consider them worthy of your company. We need each other.

And when someone calls you worthy, let it be a reminder to you that all you do to be a practical Catholic is worth your spiritual energy. I've been wrestling with that term "practical Catholic" for years. I'm saving it for a future newsletter. When the Knights expect you to be a practical Catholic, they are really asking you to make sure that you are worthy. Yes, we will give every man the benefit of the doubt, especially a man of our order. Yet you my friend, my worthy brother, must spend your energy making sure that you are worthy to inherit eternal life. Only our faith in Jesus Christ can take these poor, broken vessels of clay and make us worthy. None of us is truly worthy in ourselves. It is only because of the grace of Jesus Christ that we hope to be found worthy. As a practical Catholic, we use all the practices of the Catholic faith in hopes of being truly worthy of heaven, especially the sacraments of Eucharist and Penance.

Finally, when it comes to honors in the order, let us always remember that they are shared. When you are called to serve in a special capacity as a Knight, you are going to be greeted with the honor that we owe. Our order is founded on the principle that every Catholic man can make a difference. The honors that you receive as a knight may be for a short time or they may last longer. God has prepared you for

MEMBERSHIP CORNER

To Start off this month's Newsletter submission, I want to highlight a few of our recent successes:

Membership Highlights:

- 68 councils have been active these first 3 months in bringing in at least 1 new member (23% of our councils)
- 44 of our 61 Districts have been active these first 3 months in bringing in at least 1 new member (72% of our Districts)
- District 42 has achieved 80% of their Membership Goal for the District in the 1st quarter!
- District 64 has achieved 50% of their Membership Goal for the District in the 1st quarter!
- Council 2770 and Council 17135 in the La Crosse Diocese; Council 13480 and Council 17889 in the Madison Diocese; Council 4520 in the Milwaukee Archdiocese and Council 499 in the Superior Diocese have already achieved 100% or greater of their Membership Goal!

- In the next month or so we should be welcoming 2 new councils to our State—with one being in the La Crosse Diocese and the other a Hispanic new council in the Green Bay Diocese. At this same time, we may potentially be finalizing a new council in the Superior Diocese that would be our 1st Hispanic Council in this Diocese potentially! A big THANKS to Hispanic Council Development Coordinator Rufino Arce and team along with New Council Development Coordinator Ron Faust and team!
- The UW Madison Council, Council 6568 recently exemplified 13 new members into the Order! They are once again a leader among their college council peers!

Although these are some great success stories above, we still have much work to do to grow our membership in this State!

Our goal this year is to bring in at least enough new members to offset the withdrawals and deaths that we experience throughout the year—growing net/net positive for the first time since 2000!

To help MOTIVATE and EXCITE councils, our State leadership is once again offering an incentive this upcoming quarter (October, November and December) to promote GROWTH these next 3 months along with promoting ACTIVITIES and PROCEDURES that will help us continue the momentum into the new year!

2nd Quarter Membership Incentive:

If a council adds and exemplifies new members in October, November and December equal to 50% or greater of their MEMBERSHIP GOAL set by Supreme, then they will receive a 40% reduction on their April 1st per-capita invoice. For a council to be eligible to achieve this incentive—they will need to have scheduled and shared with the State their Church Drive and Exemplification Schedule for the 1st half of the year as well as the 2nd half of the year (January-June) before December 31st! They will also need to have attended and received credit for 1 FRATERNAL BENEFIT NIGHT for this Fraternal Year by December 31st!

Example: If a council goal is 5 new members on the year; and they have already brought in 1 new member this Fraternal year—then THEY WILL STILL NEED TO BRING IN 3 ADDITIONAL NEW MEMBERS TO REACH THEIR GOAL FOR THIS INCENTIVE. If they have brought in 0 new member—they will still need to bring in 3 NEW MEMBERS!

Example: If a Council's goal is 8 new members—then they will need to bring in 4 NEW MEMBERS (REGARDLESS OF IF THEY HAVE ALREADY BROUGHT IN NEW MEMBERS THIS YEAR) from October 1-December 31st to qualify!

I will be reaching out to each of your councils with council specific goal that is needed to be brought in these 3 months to qualify for this incentive.

To date—we are still missing about HALF OF OUR COUNCILS from submitting any membership drive, program events or exemplification dates for the first half of this year!!

Please do your best to ENSURE you qualify for this incentive by submitting this information to your Diocesan Membership Coordinator and me ASAP!

State Treasurers Updates:

Brother Knights,

Intellectual Disabilities ("Tootsie Roll") checks were distributed to District Deputies at the Diocesan Huddles held in September and by now all Councils should have received them. If you have not, please contact your District Deputy. Please present these checks to your designated charities as soon as possible so that the money can be put to good use.

October Per Capita invoices will be <u>emailed</u> to Council Financial Secretaries on October 1st. For Councils currently without a Financial Secretary, the invoice is being emailed to the

Grand Knight and for the few Councils without a Financial Secretary or Grand Knight, it is being emailed to the District Deputy. Please watch your email inbox and spam folders for the invoice. If your Council has not received it within several days after October 1st, please contact me at rbreunig@wikofc.com. Your Council's prompt payment of the invoice is greatly appreciated.

Congratulations to Councils that earned a Fast Start Incentive Credit. Those Councils will see the credit appear as a deduction on their October Per Capita billing.

Speaking of Per Capita, there are a few Councils that are behind in paying prior Per Capita invoices. Reminders have been emailed to the applicable Financial Secretaries. Please ensure that your Council has paid its Per Capita.

Council Charity Grant Request checks will be sent via <u>U.S. Mail</u> to Councils on or before October 15th. This is a little later than in prior years because we had an unusually high number of Councils that did not turn in the required Council Charity Fund Request Form that was due on May 1st. We are required to receive these forms for Raffle regulatory reasons, and, without the form, we cannot issue a check. As of this writing, there are approximately 90 Councils that will not receive a check because we do not have their form. If your Council has not submitted its form from last year's raffle, please get it to Charity Director Bernie Heit (<u>bernieheit@gmail.com</u>) promptly. We will be establishing a "hard stop" on these form submissions in the future, after which payments cannot be made.

Brother Knights,

I hope your summer is going well. As we approach the end of month 2 of the fraternal year, we are in need of getting some paperwork completed. There are 58 councils who have still not submitted Form 185. This form is essentially the roster for your council's team, please work on this.

As of today, according to Supreme, 92 councils still have not submitted Form 365. As you know this is a list of your directors who will help your council succeed. It is instrumental in providing Supreme with a list of individuals who

need to be Safe Environment Compliant. Let's work on this, please. On your 365 you must have the following positions filled: Membership, Program, Community and Family Directors.

The next topic of concern is our Safe Environment Status. Needless to say, without Form 365 and 185 Supreme cannot issue training invitations or track how a council is doing in becoming Safe Environment Compliant. It is critical that all councils become compliant for many reasons. We need to ensure that we provide a proper environment for those we deal with as well as ensuring that we do not allow situations to occur that can hurt others as well as ourselves. Of the 4 positions that require SE (Safe Environment) compliance there are many councils that have 3 of the 4 satisfied. I will be contacting those councils to see what we can do to help to complete compliance.

Last month we spoke on Love Hate Relationship of Facebook. This month I thought I would give you a little update — first Facebook is the world's most popular social media platform and is the really the optimal place to create your council's first social media presence.

Three things are important for all social media page administrators to remember:

- 1. Your Facebook page (for the most part all social media for that matter) is public!
- 2. Be positive!
- 3. Invest time in your social media

Why is my account disabled? Facebook disables accounts that might not follow "Facebook Terms". Some examples included:

- Posting content that doesn't follow the Facebook terms
- Using a fake name
- Impersonating someone
- Continuing behavior that is not allowed on Facebook and goes against their Community Standards
- Contacting other people for the purpose of harassment, advertising, promoting, or other conduct that's not allowed

The establishment of the Father McGivney Guild was certainly a milestone marking the path to our founder's canonization. It operates out of the Supreme Council office in New Haven CT. The guild serves as a clearinghouse for information regarding Father McGivney, promotes devotion to his memory, develops and distributes materials about his life and virtue, receives reports of favors received through Father McGivney's intercession, and receives news of possible miracles. Membership in the guild is open to anyone interested in Father McGivney and his cause, including members of the Knights of Columbus and their families. A guild newsletter is sent to members several times a year. All materials produced to promote information and devotion to Father McGivney are automatically distributed to members of the guild

and, once a month, a mass is offered at St. Mary's Church in New Haven.

Guild membership is now more than 178,000. The Roman process of investigation into Father McGivney's life and holiness is nearing completion, and the investigation into the reported miracle is progressing. Don't be fooled. The growth of the Guild is but one step along the way. There are over 1.8 million members of the Knights of Columbus. Why are so many so hesitant to join the Guild? We have over 35,000 members alone in Wisconsin but as of 4/1/2022 there are only 1,239 Guild member in our State. The Guild depends on us to further the message of Father McGivney. 10-year Supplement

Brother Knights

After nearly 10 years, it is supplement time again and I need your help in getting this done.

The plan is to provide you with the opportunity to have your council represented in the 2013-2022 Wisconsin Knights of Columbus Ten Year Supplement. You will be allowed to provide as much information as you can provide us. If your council has done a good job of completing and submitting the annual supplement, this will be a very easy task. If not, it will require some effort. BUT each council should submit a minimum level of information.

Guidelines

- Minimum information required
- Form available on State website
- 1st page is required to be completed and submitted
- Submit as large an entry as desired, but it may be edited.
- The entry is to be a summary of your activities for the past ten years. Do not merely submit the entries from past years. Be concise.

- The goal is to have the entries submitted electronically unless it is absolutely impossible to do so.
- Deadline 1/1/2023

Now, if some of you may recall, the previous 10-year supplement took forever primarily due to my procrastination, work schedule and my efforts to get councils to submit information. I will not be the source of delay this time as I will be finally retired. The State Council is placing it in the hands of the District Deputies to ensure an entry from each council is submitted. So, please, make his life easier and get this done as soon as possible.

The 2003-2012 supplement had a terrible participation rate. Less than 50% of the councils were represented. If a council did not submit an entry, the council's name was listed, and it was noted that information was not provided. I doubt any council wishes to see that type of representation for their council. Plus, I will not allow it. I will have something published for each council. That means I will be calling the Grand Knight or Financial Secretary.

The program coordinators are also expected to submit a ten-year supplement for their particular program. Information guidelines will be in place by 10/1/202.

Let's make this the best supplement ever.

Council Statements from Supreme

On January 1, 2022, the Board of Directors reinstated council assessments for Per Capita, Catholic Advertising and Culture of Life. As of September 1, 2022, your Council had a remaining balance on one or more of your accounts.

Council statements are available on the Reports tab in Officers Online and can be viewed and downloaded by the grand knight, financial secretary, deputy grand knight, advocate, treasurer, and membership director of your council.

To view statements online, go to **kofc.org** and select the "SIGN IN" button near the top banner. When using a mobile device, the "SIGN IN" button is in the menu. Enter your login information or call Customer Service at 800-380-9995 if you do not have your login information. Once you are in Officers Online, scroll down and select the "Reports" tab. Council Billing Statements will be an option. Clicking on the icon in the "PDF" column will provide the current statement and clicking on the word "Past" next to the report name will provide past statements.

We recognize that some councils are still struggling to recover from the pandemic and may require special consideration. If your council needs a paper statement or further assistance, please contact

What is Wisconsin Knights of Columbus Charities Inc.?

I am sure many of you ask this question, especially if you come to the State Convention. There is a 'break' in the convention, a special report given near the end of the convention and an election of Directors. That might be as much as many Knights know about Charities, Inc.

Wisconsin Knights of Columbus Charities, Inc., is not the charity committee and they have nothing to do with the yearly raffle. Charities, Inc. is a separate entity within the Wisconsin Knights of Columbus. Wisconsin Charities, Inc. is the 501(c)3 arm of the Knights of Columbus. Each Council is a 501(c)8 for tax purposes. You are charitable but you are not tax deductible for anyone giving you funds.

How does any of this benefit your council or the state?

Charities Inc. has been a great place to keep donations and funds as councils work to get an ultrasound in their area. It allows businesses to donate and get a tax deduction while helping to purchase the ultrasounds. It allows the councils to not commingle these funds as they continue to get donations.

Charities Inc., has been huge for one council who uses it in support of their Tootsie Roll Drive. Richland Center, 3492, asks businesses for donations through Charities, Inc which gives the business a deduction donation and allows the council to really increase the amount they raise. This council raises \$5,500 by the traditional drive and another \$5,450 by properly using Charities, Inc.

Charities, Inc. could be used by your council to support Special Olympics, either locally or in the Wisconsin Games Pledge.

Charities Inc. also takes unrestricted donations for the board to assist groups around the state, such as Coats for Kids, Special Olympics, and Ukraine Solidarity Fund. These groups all received funds from Charities this year.

What Charities, Inc., is not designed for is a pass through for councils to have events and business to get the deduction to pay for them. Ex: Bands, Council Christmas Dinner, Picnics, and so on

The Charities Inc. Board has 7 members: John Huttenhoff, Miles Casey, Roland Breunig, Don Schoenherr, Daniel Miller, Duane Zaborowski and Mark Jelinek.

If you have men showing there, **CONTACT** them. **INVITE** them to your Council meetings and activities. While you are together, invite them to attend an in-person or online **DEGREE** ceremony.

<u>After completing</u> the degree, **PROCESS** them into your council. If the member does not wish to join your council, please REJECT him and select the appropriate reason. Then please contact me so I may take the appropriate action based on the reasoning. DDs, please follow up with your councils.

REMINDERS:

When joining online, the requirement is that each new member must sign up **himself**.

Online membership is a way for men interested in joining the Knights of Columbus to do so online, it is **not** to be used as a data entry system to enter new members from form 100s, prospect cards or parish lists. Use the Candidate tab for that. Online membership requires a member to join with full knowledge, consent, and active participation in the process. As a reminder, if an individual does not truthfully answer all application declarations, his membership in the Knights of Columbus is void.

REQUIREMENTS:

- Every man who joins online needs to access kofc.org/joinus from a compatible device, <u>personally</u> complete the online application testifying to all the attestations and submit the online application <u>himself</u>.
- When possible, the member should use his own compatible device.
- The member must use their own valid email address when completing the online application.
- There is a new (as of 11-04-21) process in joining online. Instead of having to enter a verification code (a source of error), after the member completes and submits the first page of the online join process, which includes his email address, he is sent an email to verify the email address. That email will contain a clickable link (available for only 24-hours) to complete the join process.

Should he fail to act within the 24-hour window, he will see an error message and must restart the join process.

NOT ALLOWABLE:

- Completing the online application for a member even if they have asked you to do it for them.
- Collecting information from a proposed member on a form 100 or prospect card and using the information to sign the member up for online membership.
- Creating an email account for a member so they can complete the online membership process.

NEW MEMBER PROCESS:

Follow the standard procedures for a new e-member as with all new members:

- Completed form 100 or assigned e-member status in Prospect tab of Officers Online (OO).
- Admission committee vetting.
- Council action (voting) see <u>Guidelines for Online Voting Motions</u> if holding virtual meetings
- Degree Member must take the degree <u>prior</u> to being transferred into a council.
- Process the new 3rd degree member into your council via Form 100 submission or, Online form 100 using the Candidate tab data entry and transfer, or e-member transfer using the Prospect tab.
 - <u>REMEMBER:</u> If you use either the Prospect tab or the Candidate tab to process your new members, do NOT submit a mailed paper or scanned pdf of the form 100. It just confuses the issue and might result in duplicate entries. Use only one of the available methods.
- Update degree status by entering degree dates for 2nd & 3rd degrees in Member Management.

Did Your Council Make a Difference This Summer?

As we know councils support their families, parishes and communities through Faith in Action (FIA) programs. The Columbian Award requirements state that each council should complete 12-16 programs annually. This equates to 3-4 programs in each FIA category: Faith, Family, Community and Life.

A program is considered complete when a council submits a Fraternal Program Report (#10784). It is important for councils to submit these forms soon after completion. Submitting the form is the only way a council recieves credit for the program.

Data from the Fraternal Program Reports is leveraged by KofC leaders to monitor program progress. Further it informs leaders on which coucils are making a diffrence. It also allows leaders to identify councils that need assistance. Through the first two months of the Fraternal year only 24% of Wisconsin councils completed a progam. This is a concen as it means that 76% of councils were not making a difference this summer.

The Importance of Annual Program Planning

District Deputies (DD) have shared with council leaders the importance of annual program planning. They have also shared a council planning template, developed in Wisconsin, to assist in the planning process. It is not mandatory that councils use the planning template as long as they have a documented plan. They may use any planning tool they wish.

Councils are strongly engourged to review their plan with their Parish Priest and other key stakeholders. The review will strengthen the relationship that evey council has with its parish. Further, it will encourage Priests and other stakeholders an opportunity to share new program ideas.

New this for this year DDs are required to provide a council program status update once per quarter. The first report is due to the Dioceasan Program Coordinators (DPC) by October 15th. The infromation gathered from these reports will assist State Leadership allocate resource program resources in Wisconsin.

We support Families, Parishes and Communities through our programs. As Knights we demonstrate our faith through our programs. The success of completed council programs determine our community identity and reputation.

Coats for Kids

Did you know that many children throughout the United States go without a coat each winter? Low-income families use their scarce resources to meet the most basic needs and cannot always afford this vital winter necessity.

That's why the Knights of Columbus developed the Coats for Kids program, which allows councils across North America the opportunity to put their faith into action and purchase new winter coats at a discount for children in need in their communities. More than 800,000 new winter coats have been distributed throughout the United States and Canada since the program began in 2009.

This program's primary goal is to help kids stay warm in the winter when a child's family does not have the resources to adequately meet this need. A warm coat means a child can more realistically attend school, go to after-school programs, fit in with other children, play and do all the things that kids do to be kids. In a very real sense, a warm winter coat means mobility. Our mission is to make this seemingly small part of life a little bit easier for these families.

The secondary goal of the Coats for Kids program is to better connect your council with your parish and your community. Let the people around you see the good works of your council, so that they want to support it and be a part of it.

Into the Breach

In his apostolic exhortation Into the Breach, Bishop Thomas J. Olmsted outlines the challenges faced by men of faith in the world today. Using either Bishop Olmsted's inspirational letter or the Knights of Columbus video series it inspired, councils will prayerfully examine the crisis of religious faith in our world.

By discussing the lessons and calls to action found throughout Into the Breach, men will begin to devise a personal plan of spiritual battle to strengthen their lives, their families, and their communities.

major minority and poverty areas. Do this by mid-October!

The Culture of Life Essay Contest has been moved to January-February. Topics and updated materials packet will be announced in October and placed on the State website.

Councils should have completed their PPK and fall Soccer competitions by nw. Results should be in the hands of your Diocesan Program Coordinator soon, also send a copy to the State Forms address with your Form 10784. DPCs will be hosting Diocesan Contests in October as needed and determining the Diocesan PPK/Soccer winners to be advanced to the State Contest. The State Finals will be held at De Pere High School on Saturday, November 5.

Now is the time that all Councils should be arranging for their schools, parishes, homeschoolers, etc. to be prepared to participate in their "Keep Christ in Christmas" programs (posters, yard signs, magnets, Posada, etc.). See the State and Supreme websites for more information and supplies. Remember that we are recommending that all Councils submit their Council-winning posters for Grades 1-4 to the State "True Meaning of Christmas" Contest (to DPCs) by December 31. Every opportunity should also be made to solicit 5-year-olds and 10-14-year-olds to participate by submitting their Council-winning posters to me no later than January 15.
