

I began my 20-page State Deputy Report (entire report has been posted on the State Website) by stating "Pride, Service and Responsibility". When I took the office of State Deputy, I dedicated my term to Father McGivney and I asked each attendee at the convention to take Pride, in themselves as Knights, renew their Service obligation to our Mother Church, our Bishops and Priests, and take Responsibility to grow our order by asking each eligible Catholic man to join us. This past year the state officer team has met many challenges set before them and our watchword "Nunc Coepi" now I begin has been a constant reminder that every time we fell or thought we are falling, we needed to pick ourselves up keep Father McGivney's vision alive and move forward (that God will provide). I hope to explain where we have had areas of success and areas we need to improve upon and give some examples of Faith in Action around our state. To quote Pope Benedict XVI "Was not this unity of vision and purpose – root-

ed in faith and a spirit of constant conversion and self-sacrifice – the secret of the impressive growth of the Church in this country? We need but think of the remarkable accomplishment of that exemplary American priest, the Venerable Michael McGivney, whose vision and zeal led to the establishment of the Knights of Columbus." Gentlemen, we need not only live up to this vision, but we must live it and embrace it.

Knights in Action

On Sunday April 28th at Holy Family Catholic Church at the KC Pancake Breakfast, the Father Dodge Knights of Columbus Council 7827 presented Tammy Dallman, Director of New Dawn Pregnancy Center a \$6000 check for the down payment of the Ultrasound machine which is now on order and scheduled to arrive at New Dawn in late May.

Council 7827, along with Councils 3842 Pewaukee, 2032 Rhinelander, 3557 Lac du Flambeau. and 5415 Eagle River and Churches and parishioners from all across Northern Wisconsin not only raised the \$13,000 for the Ultrasound but also raised almost \$10,000 to help pay for a 3 year service plan and the training and set up of the Ultrasound. The Knights of Columbus Supreme will be paying for the other half of the purchase price of the Ultrasound.

Ceremonials

- Coordinates installation of council officers with district deputy.
- Schedules and publicizes frequent First Degrees.
- Confers with district deputy for Second and Third Degrees.
- Arranges Mass for departed brothers.
- Awards certificates, cards and pins during "Honorary Membership" and "Honorary Life Membership" ceremonials.
- Maintains proper conduct of ceremonials at regular meetings.

Duties

- ♦ Appoints a council chaplain.
- Appoints a membership director to organize and implement the council's recruitment, retention and insurance promotion action plans.
- Appoints Program Director to organize and implement the council's service programs.
- Appoints standing committees.
- Schedules and presides at council officers' meetings.
- Regularly monitors the council's performance toward achieving its membership, insurance and Service Program goals and awards.
- Appoints admission committee and makes sure it functions properly.
- Recognizes honorary and honorary life members.
- Recognizes past grand knights, "Knight of the Year," community leaders, etc.

Has your Council made a donation to PKD (Penny a Knight a Day), Respect Life or the Special Olympics?

- Conducts semi-annual council audit with trustees in January and July.
- Ensures forms, i.e., election of officers, appointments, awards, Fraternal Survey, etc., are completed by appropriate council officials and forwarded to the Supreme Council.
- Organizes and/or supervises First Degree team. Schedules and announces degree dates.
- Arranges for council representation at wakes and memorial services for deceased brothers.
- Arranges for "Resolution of Condolence" for family of deceased.
- Oversees preparation of annual reports from all officers and standing committees for council files and incoming officers.
- Obtains and acquaints the booklet, "How to Conduct a Meeting — Parliamentary Procedure."
- Starts all Council Meetings on Time.

State Program/Community Director

Brothers,

It was great to see and speak with so many of you at the State Convention in Appleton this past weekend. I'm happy that so many enjoyed all the displays we had for so many of our State and Supreme programs as well as other groups who were present.

For the Wisconsin Outstanding Council Award charts that were displayed, I saw and spoke to many who were wondering why many columns of information for their Council were not checked off. The simple reason is that I don't have the necessary reports to credit them! I can't give credit for programs that I don't know about. While I do get some information from Supreme and some from our State Coordinators such as Charity Raffle, ID Drive, Roundtables, etc., which are still being complied, there are many programs that Councils have completed that I don't know about yet.

So, Council need to:

- 1) Fill out your Fraternal Activity Report forms for each of your programs you've done and submit those to Supreme and to our State Forms address (form@wikofc.com) SOON!!
- 2) Fill out your Wisconsin Outstanding Council form and submit it to the State Forms address by June 30, preferably before. The form is on the State website.
- 3) Fill out your Supreme Columbian Award form and send it in to Supreme with a copy to the State Forms address by June 28, preferably well before that date! (June 30 is a Sunday so it has to be in by Friday!)
- 4) If you have not submitted some type of print or electronic History Book, it's required for the Wisconsin Outstanding Council Award. Get it to me by June 1 if at all possible, no later than June 30.

5) Remember that to earn the Columbian Award and Star Council, you have 4 new required Faith in Action programs that must be done for 2018-19: Spiritual Reflection Program (Faith), Consecration to the Holy Family (Family), Helping Hands (Community), and Novena for Life (Life). If not already done, you have 2 months left to do so. If not done, you cannot earn these awards!

It saddens me that we have so many Councils who do such good work, but simply do not do the recruiting, paperwork and/or requirements to earn these honors. In addition to the items listed above, many Councils will miss out on Star or Outstanding Council because they fell short on their recruiting and/or insurance quotas. At the Convention this past weekend, our Worthy Advocate reported that only 30% of our Councils are in full compliance for the Child Safety Requirements that were mandated to be completed by May 1. So, 70% of our Councils are thus ineligible for Columbian and Star Awards!

I know that for 2019-20 we can do better, so do what you can for this year and vow to go the extra mile to double, triple what we can attain for this year. Nunc Copei - Now We Begin! Vivat Jesus!

Good of the Order Report

To the State Officers & Members of the Wisconsin

State Council of the Knights of Columbus:

This year's committee consists of PSD Wenzel Felber, FSO Dr. Thomas Rudolph, FDD Allen Christianson, FDD Peter Denissen, and FDD James Zoellner. They bring an array of views having served in almost every Officer position and as Chairman of many of the State Programs. This committee is pleased to announce that the current State Officers have operated the State Council within budget guidelines and have adhered to the By-Laws & Policy Manual.

What is Wisconsin known for? A non-resident of the state might say the Green Bay Packers, Wisconsin Badgers, Milwaukee Brewers, Bucks, Milk, or Cheese Heads. Former Supreme Knight Virgil Dechant said "Wisconsin is known for Programs".

Supreme Knight Dechant's statement from the nineties now asks the question are Wisconsin Councils and Districts Progressive, Regressive, or Stagnant? The Good of the Order Committee feel's the number one issue holding Wisconsin from moving forward is a lack of program growth within the State.

On July 1, 1987 the Wisconsin State Council membership was 41,407 with programs growing. As of July1, 2018 the state membership stood at 35,904 with programs struggling. What changed?

In order to analyze this one must look at the history of the past 30 plus years. From 1987 to 1994 the state membership declined to 39,901. Then from 1995 to July of 2000 the state membership rebounded to 40,009. From July of 2000 the state membership dwindled each year to the July 1st 2018 figure of 35,904. It should be noted that data used in this report is from July 1st 1987 to July 1st 2018.

In 1994 the state team realized that even though over 1400 members were being added each year the overall membership had declined to 39,901. They also noticed that programs were remaining stagnate or dwindling. In an effort to revive programs within Councils, the State initiated the Wisconsin State Complete Council Award. As you know, the Award is based on Councils doing projects in all areas of Youth, Council, Community, Church, and Family. The award is round indicating that no program is more important than another. However membership is on the top indicating that programs support membership and membership is the life blood of programs. Another challenge was Baby Boomers were moving south by the hundreds and transferring their membership to the new states causing large losses in total membership. In 1998 the State Deputy started contacting members in good standing living within the state but belonging to councils of other states encouraging them to join a local council. These two initiatives resulted in every program within the state growing, except Squires. It reversed the member-

ship losses and allowed the State to grow back to 40,009 by July of 2000.

During the time frame from 2001 to present our state membership has declined each year. This was despite many different efforts including new programs and membership promotions by every State Deputy and State Officer. Why? No one knows for sure but here maybe some of the factors:

- 1) Since 2001 Supreme has changed the requirements for state council awards several times.
- Supreme changed from Surge with Service to Building the Domestic Church. On July 1, 2018 Supreme merged "Building the Domestic Church" into Faith in Action.
- 3) Economy.
- 4) Baby Boomers passing on & moving south.
- Less personal contact with membership (i.e. too much reliance on the computers to get the message out).
- 6) No one talks to anyone anymore.
- 7) Leaders placing too much emphasis on one program over another.
- 8) Councils not expanding their horizons doing the same programs year after year.
- 9) Members not stepping forward and becoming leaders (i.e. District Deputies & Coordinators).
- 10) Careless use of State budgeted funds.

Regardless of the reason, by the close of the books on June 30th 2018 every program (except tootsie roll) had declined or failed to grow. Membership growth hit an all-time low. Who or what is to blame? Let's all look in the mirror!

What is the answer? How do we finally reverse this trend and become the leader Wisconsin can be?

Prayer is a powerful force and asking Father McGivney to intercede to the Lord on our behalf is a good thing. However, Father McGivney might tell us our Lord has already given us the tools to succeed.

With that in mind, and even though under the leadership of SD Wrbanich it does appear Programs are rebuilding, The Good of the Order Committee still recommends the following steps. These steps will ensure Wisconsin has Progressive Councils and Districts which will make the State Council grow!

Councils:

- 1) Take an honest look and your Council! Does your Council do the same things each year, or do you fluxuate and help people as things arise?
- 2) Stop stressing over the new report forms nothing has changed except Church is now call "Faith", Youth has merged into "Community", Council has merged into "Family", and Pro-Life is now called "Life". You can still have someone take on different duties within a program. (Example one person can do the youth programs and someone else can do the blood drive.)
- 3) Challenge each Faith, Community, Family, and Life Director to add one new program. There are 4 required programs to earn the Columbian Award. The purpose of a new program (it might be a one-time thing) is to stir up interest from another group of men. Remember we are all different and we all enjoy different programs.
- 4) Recruit all ages of men, but stop stressing over not getting new younger members. Remember 55 to 65 year old men are retiring, get them, they need to have something to do. Their wives want them out of the house.
- 5) Maintain your council membership. Make your council a plus one over all losses. Replace <u>every</u> lost member from deaths, withdrawals, transfers or suspensions with a New Member.
- 6) Personally contact each and every member at least once a year? Call them on their birthday! Make sure they are getting the newsletter, ask if they need any help, and be a **Brother Knight.**
- 7) Set up and have a "Round Table Coordinator" for each Parish your Council supports. Make sure they do projects within each parish. A name on a paper does not help the parish nor does it get new members for your council! Our committee feels this is so important that it is asking the State Deputy to increase training for both Council Officers & District Deputies.

District Deputies:

- District Deputies visit your Councils and challenge them to expand their horizon. Complete your semi-annual report on each council to the State Deputy. Be honest with your report. The State Deputy cannot do his job if he does not know the correct status of each and every council.
- 2) District Deputies ensure your Councils understand the "Faith in Action" program. Review the "Faith in Action" hand out with your Councils. Each Council received a training manual from Supreme. The Supreme "Webinar" is another excellent training tool.

State Officers and Directors:

- State Deputy: Continue to promote all programs.
 Contact members living in Wisconsin that belong to other states and encourage them to transfer to a local council.
- 2) State Secretary: Use the funds set up in the By-Laws and ensure a Badger Bulletin is mailed to every member of our state at least once a year. Do a recruitment promotion on the front page. Do this early in the fraternal year.
- 3) State Treasurer: Continue operating the State within budgeted guidelines.
- 4) State Advocate: Insure the State council follows the By-Laws and uses the Policy Manual.
- 5) State Warden: Be the Right Hand of the State Deputy.
- 6) State Officers: Use common sense, history shows membership growth does not come from spending large sums of money on a promotion. Membership growth comes from talking to a prospective candidate and asking him to be a Knight.
- State Coordinators and Directors: Take a good honest look at your program maybe it can be improved.
 Remember changes cannot be done without approval of the State Deputy.
- 8) Good of the Order Committee: Assist the State Officers in order to find more ways to promote and assist Councils & Districts. Monitor the councils to see if they are expanding and report to the 2020 Convention said findings.

If each and every one of us does our job maybe we will hear Supreme Knight Anderson say "When I think of Wisconsin I think of Programs" and with fixing our programs we will increase our membership. In closing there is no right or wrong answer to move forward but there is an old statement in sports "Have fun out there" and as Larry the Cable guy would say "Get'er Done".




Below is a summary of our progress to date.

RE: 2018 Tax Information for KofC Councils, Assemblies, & Chapters

This notice is to remind councils, assemblies, and chapters in the United States of their legal obligation to file an IRS Form 990 (informational tax return) for the 2018 tax year, and to provide detailed instructions on how to comply with this obligation. At the present time, due to the government shutdown, the IRS website is not fully operational, and cannot be utilized for filing Forms 990-N. We do not know when it will be fully operational. Councils submitting paper returns (Forms 990-EZ and 990) may file through the United States Postal Service.

The Knights of Columbus, including all subordinate councils, assemblies, and chapters (collectively referred to as councils), is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. This tax exempt status requires each council to file an annual Form 990 with the IRS.

Councils reporting gross receipts of \$50,000 or less may comply with their obligation by filing the Form 990-N electronic postcard (also known as the e-Postcard). Councils with total assets of less than \$500,000, and reporting gross receipts of more than \$50,000 but less than \$200,000, must file the Form 990-EZ. Councils with total assets exceeding \$500,000, and reporting gross receipts of \$200,000 or more must file the Form 990.

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if a council's accounting period ends December 31, it must file a tax return by May 15 of the following year; if a council's accounting period ends June 30, it must file a tax return by November 15. The IRS assigns the accounting period and it does not always coincide with the Fraternal Year of the Knights of Columbus.

Need more time to file a Form 990?

Although the IRS does not grant extensions for filing the Form 990-N (e-Postcard), the IRS will accept late filings if the tax return is received within three years of the due date. The IRS will grant extensions to organizations filing paper returns (Forms 990EZ and 990). A council needing more time to file its return must request an extension at least one month before the due date. For example, if the council's accounting period ends December 31, it must request an extension no later than April 15; if the council's

accounting period ends June 30, it must request an extension no later than October 15. Federal law imposes a penalty of \$20 per day, up to a maximum of \$10,000, or five percent of the council's gross receipts, whichever is less, for incomplete or late filings. Where to file

Form 990-N (e-Postcard)

The Form 990-N (e-Postcard) must be filed online. In order to utilize the online filing system, all new users must complete a onetime registration, even if the user was previously registered under the old system (pre-2016).

If the IRS website will not allow you to file a Form 990-N

The electronic filing system for the Form 990-N (e-Postcard) may not accept a council's return if (1) the council EIN has been revoked for failing to file for three consecutive years, (2) the council's EIN has recently been reinstated, (3) it is a new council, or (4) the council is not on the Supreme Council's Group Exemption List (updated continually by the Knights of Columbus Legal Department). Officer Use Of Debit and Credit Cards

Officers may use personal credit and debit cards to conduct Council business, provided that they do so in accordance with Council by-laws and any other procedures established by the Council for the expenditure of funds.[1] Councils should understand, however, that while debit and credit cards offer convenience, they also present serious and substantial risks. In order to mitigate those risks and to ensure a full and transparent accounting of all funds, the Supreme Council strongly urges Councils to follow the "best practices" set forth below. Failure to follow these best practices will disqualify a Council from recovering losses from fraud or embezzlement under the Supreme Council bonding program.

1. Written Policies: Councils should establish clear and specific written policies regarding the use of debit

and credit cards, including the purposes for which the card may be used, who may hold use a card for Council business, who is liable for misuse of the card, and who is responsible for payment of bills. The written policy should state that debit and credit cards may be used only for expenses that have been duly authorized in accordance with the Council by-laws and procedures relating to the expenditure of funds. In addition, the written policy should set forth a transparent and accountable procedure for reimbursement. 2.

Application for Cards: Councils should NOT apply for credit or debit cards. To the extent that a

Council concludes that its officers need a credit or debit card to conduct Council business, the Council should specifically designate which officers may use a debit or credit card. These officers should apply for the cards in their own names and NOT in the name of the Council. 3. **Guarantee:** Councils should NOT guarantee credit cards. 4. **Separate Accounts:** Credit and Debit cards should NOT be connected to the Council's operating

accounts. 5. Expense Receipts: The Council should reimburse an officer only after he has submitted a detailed

voucher, including original invoices and receipts. The details should be reviewed and approved by the Council Treasurer. If the Treasurer holds a card, the voucher should be reviewed and approved by the Council Financial Secretary. 6. **Acceptable Expenses & Reimbursement:** Councils should identify permissible expenses (e.g., travel,

supplies, convention costs) and impermissible expenses (e.g., payment of council dues). If a credit card is used exclusively by an officer for Council business, it is reasonable for the Council to reimburse the officer for the annual credit card fee; it is not reasonable to reimburse late payment penalties or interest.

[1] For purposes of this entry, "Council" refers to all state and local councils, assemblies, and chapters.
